AN ORDINANCE OF THE BOROUGH OF HANOVER, YORK COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 2215 AND ADOPTING THE RATES, RULES AND REGULATIONS CONTAINED IN SUPPLEMENT NO. 34 TO WATER - Pa. P.U.C. NO. 3

NOW THEREFORE, BE IT HEREBY ORDAINED AND ENACTED, by the Borough Council of the Borough of Hanover, York County, Pennsylvania, as follows:

SECTION 1. Rates and Charges

Beginning March 28, 2022, the water rates for sales of water and consumption charges outside the municipal boundaries of the Borough of Hanover shall be increased as set forth in Supplement No. 29 to Water-Pa. – P.U.C. No. 3 attached hereto as Exhibit "A" and incorporated herein in its entirety.

SECTION 2. Severability

If any section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance. The Borough of Hanover hereby declares that it would have passed this Ordinance, and each section, subsection, clause or phrase thereof, irrespective of that fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

SECTION 3. Repealer

All Ordinances or Resolutions or parts of Ordinances or Resolutions which are inconsistent herewith are hereby repealed to the extent that the same are inconsistent with the terms of this Ordinance. Nothing in this legislation hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

SECTION 4. Codification

The Code of the Borough of Hanover, as amended, shall be and remain unchanged and in full force and effect except as amended, supplemented and modified by this Ordinance. This Ordinance shall become a part of the Code of the Borough of Hanover, as amended, upon enactment.

SECTION 5. Effective Date

This Ordinance shall take effect and be in full force and effect immediately.


