I / We agree that failure to satisfy invoices for services provided, including those for damage to the meter, may result in service termination and/or appropriate legal/collection action, including municipal/judgement lien against the property.

For ownership within the Hanover Borough, I / We agree that this application also applies for sanitary sewer service and charges of the Borough as well as stormwater service and charges on behalf of the Hanover Borough Stormwater Authority, both under rules and regulations codified and available on the Borough’s website ([hanoverboroughpa.gov](http://hanoverboroughpa.gov)).
