RESOLUTION

**A RESOLUTION LEVYING TAXES FOR THE FISCAL YEAR 2021 IN THE
BOROUGH OF HANOVER AND FIXING COLLECTION RATES THEREON.**

WHEREAS, July 2, 2019 House Bill 548 PN 887 51 amended Title 8 (Boroughs) and Title 11 (Cities) of the Pennsylvania Consolidated Statutes to: (1) authorize boroughs and cities of the third class to adopt the annual tax millage rate by resolution instead of by ordinance when the tax rate will remain the same or lower than the previous year; (2) require tax rate resolutions to have the same recording and codification requirements as ordinances; and (3) relating to Title 8 only, extend the veto power to include annual tax resolutions, and require the rate of taxation to be expressed in dollars and cents; and

WHEREAS, Ordinance No. 2280, passed December 19, 2018 levied taxes for the fiscal year 2019 in the Borough of Hanover and fixed collection rates thereon as follows:

SECTION 1. That a tax of 5.65 mills be, and the same is hereby levied and assessed for the fiscal year 2019 on each dollar of taxable real property and made taxable by the Commonwealth of Pennsylvania for County rates and levies.

SECTION 2. That the taxes herein levied are available for expenditures in the adopted budget or its supplements for the fiscal year 2018 [sic] as the same is set forth in the minutes of Council.

SECTION 3. That the compensation payable to the Tax Collector for the collection of taxes for the fiscal year 2019 is hereby fixed at ninety-five hundredths (0.95%) percent of the amount collected.

SECTION 4. That the proper officers of The Borough of Hanover be and they are hereby authorized and directed to prepare, and issue to the Tax Collector of The Borough of Hanover said warrant for the collection thereof; and

WHEREAS, Hanover Borough Council hereby resolves that Sections 1 through 4 of Ordinance 2280 as noted above are hereby approved to remain at the same rates for the year 2021.

NOW THEREFORE, be it RESOLVED, and it is hereby RESOLVED as follows:

SECTION 1. That a tax of 5.65 mills be, and the same is hereby levied and assessed for the fiscal year 2021 on each dollar of taxable real property and made taxable by the Commonwealth of Pennsylvania for County rates and levies which is \$ 0.565 on each One Hundred (\$100.00) Dollars of assessed valuation of taxable real property.

SECTION 2. That the taxes herein levied are available for expenditures in the adopted budget or its supplements for the fiscal year 2021 as the same is set forth in the minutes of Council.

SECTION 3. That the compensation payable to the Tax Collector for the collection of taxes for the fiscal year 2021 is hereby fixed at ninety-five hundredths (0.95%) percent of the amount collected.

SECTION 4. That the proper officers of The Borough of Hanover be and they are hereby authorized and directed to prepare, and issue to the Tax Collector of The Borough of Hanover said warrant for the collection thereof.


